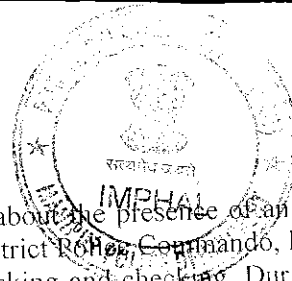


PRESS RELEASE

1. On 18/04/2017 @ 11:20 a.m, acting on a reliable information about the presence of an active members of KPLF/KPLA in and around Lamlong Bazar, a team of District Police Commando, Imphal East rushed to the eastern side of Lamlong Bridge and conducted frisking and checking. During the frisking and checking, one S/S Sergeant of KPLF(Kuki Peoples Liberation Front), who is presently holding the post of In-Charge Finance Secy namely Letginhao Haokip @ Martin (33) yrs S/o (L) Mangthang Haokip of Bongbal Kholen, P.S- Saikul was arrested. Incriminating articles along with two monetary demand letters of KPLF/KPLA were seized from his possession.

A case has been registered at Porompat Police Station and investigation is going on.

2. On 18/04/2017 at @ 11:30 p.m, acting on a reliable information about the presence of armed underground elements in and around Wangjing-Heirok Bazar area, a combined team of District Police, Thoubal and 2nd AR rushed to the area and conducted frisking and checking at Wangjing, near Canteen Lampak. During the frisking and checking, two active members of the banned organisation, KCP namely, (i) Taorem James Khuman @ Nongdomba (24) yrs S/o T. Ibomecha Khuman of Mayang Imphal, IB Raod and (ii) Thounaojam Surjit Singh @ Mamo (34) yrs S/o Th. Sharat Singh of Utlou Kangjeibung Mapal was arrested. One 9mm handgun loaded with 3(three) live rounds was seized from Taorem James Khuman @ Nongdomba. Incriminating articles were also seized from their possession.

A case has been registered at Thoubal Police Station and investigation is going on.

3. On 19/04/2017 at @ 02:10 p.m, acting on reliable information about the presence of an active members of the outfit organisation KCP (Nongdrenkhomba) in and around Thambalkhong area, a team of District Police Commando, Imphal East rushed to the area and conducted cordon and search operation at Wangkhei Thambalkhong Lisham Leirak. During the operation, S/S Sergeant Major of UNLF, presently working as an active member of KCP (Nongdrenkhomba) namely, Lisham Ibungotomba Singh @ Punshilemba (38) yrs S/o L. Kunjamani Singh of Wangkhei Thambalkhong Lisham Leirak was arrested from his residence. Incriminating articles along with one monetary demand letter of KCP were seized from his possession.

A case has been registered at Porompat Police Station and investigation is going on.
